GERS ANNOUNCES UPCOMING ELECTION OF RETIREES TO THE GERS BOARD OF TRUSTEES

ST. THOMAS, VI –

GERS ADMINISTRATOR, AUSTIN L. NIBBS, WISHES TO ADVISE RETIREES THAT IN ACCORDANCE WITH ACT 6794 WIDELY KNOWN AS THE REFORM ACT OF 2005, GERS WILL BE CONDUCTING ELECTIONS FOR ONE (1) RETIREE FROM EACH DISTRICT TO SERVE ON ITS BOARD OF TRUSTEES.

ELIGIBILITY REQUIREMENTS STATE THAT ONLY RETIREES OF THE GOVERNMENT WHO ARE MEMBERS OF THE SYSTEM ARE ELIGIBLE TO VOTE AND SEEK ELECTION TO THE BOARD.

EACH CANDIDATE SHALL HAVE AT LEAST FIVE YEARS EXPERIENCE AND AT LEAST A BACHELOR'S DEGREE IN ANY OF THE FOLLOWING: INVESTMENT BANKING; ECONOMICS; FINANCE; INSURANCE; LAW; MEDICINE; ACCOUNTING; ACTUARIAL SCIENCE, TAXATION; REAL ESTATE APPRAISAL OR BROKERAGE AND SECURITIES TRADING.
