GERS TO ACCEPT RETIREE PERSONAL LOANS FOR NEW \$50,000 MAXIMUM AND ANNOUNCES SUSPENSION OF LOANS PROCESSING FROM SEPTEMBER 30TH – OCTOBER 4TH

THE GOVERNMENT EMPLOYEES' RETIREMENT SYSTEM (GERS) IS PLEASED TO ANNOUNCE THAT APPLICATIONS FOR RETIREES LOANS WILL BE ACCEPTED AT THE INCREASED MAXIMUM AMOUNT OF \$50,000 BEGINNING SEPTEMBER $23^{RD} - 27^{TH}$.
