



## Election Special

**I**n accordance with Act 6764 frequently referred to as the Reform Act of 2005, retirees who serve on the GERS Board of Trustees will now have to be elected by their peers.

Administrator, Austin L. Nibbs who serves as the election supervisor along with election committee members in both districts began the process earlier this year once the procedures were drafted and approved by the Board of Trustees. Advertisements were placed in the newspapers as well as press releases were sent to the media informing members about the election, the requirements and the timeline. This information was also placed in GERS' second and third quarter newsletters and on our website.


In the St. Thomas/St. John District, we received four (4) nomination packages; whereas, in the St. Croix district, we did not receive any packages by the deadline. As a result, upon the recommendation of the election supervisor, the Board voted to extend the deadline in the St. Croix district only, for an additional thirty (30) days. Administrator Nibbs also sent a personal plea to all retirees in the St. Croix district by way of a letter, again informing them about the election and sharing the benefits of serving on the GERS Board. When that deadline closed out, we received five (5) nomination packages.

Based on the requirements, as stipulated by law, there were two (2) successful candidates in both the St. Thomas/St. John District and the St. Croix District. One nominee in the St. Thomas/St. John District filed an appeal/challenge, which in turn, delayed the process as we had to await a decision. Hence, the election timeline had to be amended. That appeal has since been resolved and we are now prepared to move forward.

The election is scheduled for **January 2011** and will be done by way of mail-in ballots. We have procured the services of a reputable third party vendor, VR Election Services (VRES), headquartered in Dallas, TX. Celebrating their 26<sup>th</sup> year anniversary, VRES are the undisputed leader in Retirement System elections throughout the United States.

Election ballots will be mailed to all eligible retired members of the GERS beginning January 7, 2011. Those members will have until February 21 to vote and return their ballots through the mail in the prepaid reply envelope to VR Election Services.

VRES will count the votes and the outcome will be announced at the next scheduled regular board meeting of the GERS Board of Trustees.

With this being our first election, we strongly encourage you to participate in this very important process.

# VOTING

Q: Who's eligible to vote?

A: All retirees of the Government who are members of the System and currently receiving a monthly annuity or disability benefit from the GERS.

Q: When will retirees receive their mail ballots?

A: You can expect to receive your mail ballot any time after the first week of January. They will be mailed directly to eligible retirees by VR Election Services.

Q: How does the voting process work?

A: Once you receive your ballot package, please review the materials and the instructions. You then vote on the bar-coded ballot by simply making a mark in the response box next to the candidate of your choice for Board member in your district. When finished, utilize the included Business Reply Envelope to return your completed ballot to VRES's secure tabulation facility. Once there, the ballots are verified, sorted, scanned processed and secured.

Be assured that there is complete voter anonymity, accuracy, total security and quality control.
